Track Coaches and Activities Directors:

The Pioneer Conference High School Track Meet will be held on Saturday, April 26, 2008 at Auburn.

The scratch/add meeting will take place at 8:30 a.m. Field events are scheduled to begin at 9:00 a.m. Running events will begin at 11:00 a.m. or soon after.

Meet information and responsibilities are enclosed. For the field events, each school will be in charge of either a boys or girls event. FCSH will do both girls and boys pole vault. I have assigned curve and hurdle judges as is done at districts. Just a reminder to bring stop watches and tape measures to help run your event.

In the field events, each entrant in the long jump, triple jump, shot put, and discus will have three attempts in the finals in those four events. Starting heights for the high jump and pole vault will be determined when all entries are in. In all running events that have preliminaries, the top eight preliminary times will qualify for finals. No spikes longer than 1/8" are allowed. You may enter three individuals in each event but only one relay team. The scoring for the meet will be 10-8-6-4-2-1
